

General rules:

1. All Members and Guests shall read and follow these Range Rules.
2. All Members and Guests shall sign in prior to participating in any shooting.
 - 2.1. Members are responsible to insure the Guest has completed the Guest Waiver, which are in the Waiver book.
 - 2.2. Members are responsible for their Guests activity.
 - 2.3. Members of other clubs attendings OSRC sanctioned events involving Restricted firearms (i.e. WOHL) also need to sign the log book
 - 2.4. Guests may attend a maximum of 6 times in total.
3. All restricted firearms must be locked and boxed; and all non restricted firearms must be cased, except:
 - 3.1. when in use on the range
 - 3.2. while being transferred between the range and the safe area
 - 3.3. while being inspected at the safe area.
4. All firearms shall be proved safe upon unboxing/uncasing and immediately prior to boxing/casing.
 - 4.1. All Persons shall Prove every firearm safe upon initial handling.
 - 4.2. Always keep the muzzle pointed in a safe direction at all times while doing so
5. Smoking is not permitted anywhere inside this building at any time.
6. Food and drink is not permitted on the range.
7. Persons impaired by alcohol or drugs (legal or otherwise) are not allowed on this property.

Range use rules:

8. IPSC and IDPA disciplines shall not be shot at this range, it is not approved for such.
 - 8.1. Holsters shall not be worn unless approved by the Board.
9. Firearms approved for use at this Range are;
 - 9.1. All air and CO₂ powered firearms
 - 9.2. Rimfire rifles chambered in .22long; .22short; and .22long rifle
 - 9.3. All rimfire handguns chambered in .22long; .22short; and .22long rifle
 - 9.4. All centerfire handguns chambered in the calibers listed in section 21
 - 9.5. Rifles chambered in pistol calibers used in Cowboy action shooting events
10. Ammunition approved for use at this Range are:
 - 10.1. Pellets and other caseless ammunition
 - 10.2. copper alloy jacketed bullets

- 10.3. lead bullets
 - 10.4. Steel-jacketed and steel-core ammunition NOT allowed at any time
11. Members must be accompanied by another person;
- 11.1. who is 16 years of age or older;
 - 11.2. who shall remain inside the building;
 - 11.3. and is capable of summoning help should it be needed;
 - 11.4. in order to use firearms described in S9.3 and s9.4
12. A Range Officer must always be appointed when the Range is in use
- 12.1. The Range Officer's decisions shall be final regarding any issues on the Range
 - 12.2. All persons shall abide by the Range Officer's commands
 - 12.3. The Range Officer will command when firearms may be handled.
 - 12.4. The Range officer will control when the range is active for shooting by:
 - 12.4.1. Commanding "hearing and eye protection on"
 - 12.4.1.1. Hearing protection not required when only air powered firearms in use.
 - 12.4.2. Activating the RED light to indicate the range is active
 - 12.4.3. Commanding when loading and firing can commence
 - 12.5. The Range officer will control when the range is inactive for shooting by:
 - 12.5.1. Commanding "make firearms safe".
 - 12.5.2. Commanding "stand behind cease fire line"
 - 12.5.3. Inspecting all firearms on the bench.
 - 12.5.4. Activating the GREEN light to indicate the range is inactive for shooting
 - 12.6. The Range Officer shall control entry and exit from the shooting line.
 - 12.7. If no one is willing to be Range Officer then shooting shall cease.
 - 12.8. Prior to commencing and at the conclusion of shooting the Range Officer shall inspect the range for damage and record any in the RO Log book; accompanied by any shooter who wishes to do so.
13. When a "Cease Fire" is called, all persons shall immediately prove their firearms safe and place them on the shooting line bench for inspection by the RO, then proceed to stand behind the cease fire line.
- 13.1. Anyone can call a Cease fire
 - 13.2. Any firearm that cannot be made safe shall be held in a safe manner by the operator until the RO can assist them to make their firearm safe. If the firearm cannot be made safe with available tools and expertise, it may be carefully placed inside the steel storage box under Port #7, the door secured with the provided lock, and the key taken with you while leaving the range temporarily to obtain adequate tools or assistance.
 - 13.3. Loaded firearms shall not be placed on the bench unattended.
 - 13.4. Once a Cease Fire has been established, no firearms shall be handled until the RO commands as per s12.2

14. While being handled; Firearm muzzles must always be pointed in a safe direction, which can be
 - 14.1. Down range; or as indicated in the safe area; or
 - 14.2. As commanded by the RO

15. Centerfire firearms must be discharged in ports 2 to 7 only.

16. Only paper targets shall be used;
 - 16.1. The top of which is pinned to the cork line or lower
 - 16.2. The aiming point is in the window area of the target holder as much as possible.
 - 16.3. Targets shall be at least 10 meters from the firing line when being fired upon.

17. Firing shall be through the shooting ports only:
 - 17.1. Port 5 to be used only when needed for competitions or for wheelchair shooting.
 - 17.2. Target sight picture shall be acquired prior to firing
 - 17.3. Shooters shall follow the contents of the CFSC & CRFSC regarding range courtesy and proper loading & firing technique.

18. No one shall be down range unless a Cease Fire has been called
 - 18.1. Follow directions in s13
 - 18.2. Shooting in the downrange area may be permitted for specific activities upon approval by the Board.

Direct and Immediate Supervision

19. All shooters on the firing line that are:
 - 19.1. Non PAL holders must be under the Direct and Immediate Supervision of their Host or the RO to shoot ANY class of firearms.
 - 19.2. Non RPAL holders must be under the Direct and immediate Supervision of their Host or the RO to shoot Restricted class firearms.
 - 19.3. Shooters listed above; awaiting their turn shall remain behind the cease fire line until directed by the Supervising Host or RO

20. The Supervising person shall:
 - 20.1. remain within arm's length of the shooter
 - 20.2. continuously monitor the shooter
 - 20.3. not be shooting while supervising.
 - 20.4. Advise the RO of the situation prior to commencing shooting.

21. Handgun Calibers currently approved for use at Owen Sound Revolver Club are:

- 21.1. 32 ACP and 25 ACP
- 21.2. 32 S&W long
- 21.3. 9mm Luger also known as 9x21 and 9mm Para; 9mm Makarov
- 21.4. 38 ACP and 380 auto
- 21.5. 38 Special and 38 S&W and 38 Super auto
- 21.6. 357 Magnum
- 21.7. .41 Magnum
- 21.8. 44 Special and 44 Russian
- 21.9. 44 Magnum
- 21.10. 45 ACP and 45 Long Colt
- 21.11. 10 mm Auto
- 21.12. 40 S&W
- 21.13. 7.62x25 Tokarev
- 21.14. Other calibers may also be approved, please ask the RSO.

22. Definitions of short forms

- 22.1. RO means Range officer
- 22.2. RSO means Range Safety Officer – an Officer and Director of the Club
- 22.3. PAL means Possession and Acquisition License
- 22.4. RPAL means Restricted Possession and Acquisition License
- 22.5. CFSC means Canadian Firearm Safety Course
- 22.6. CRFSC means Canadian Restricted Firearm Safety Course
